## ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFFS

Issue Date: November 19, 2010

Effective Date: November 29, 2010

On November 1, 2010, the Staff of the Missouri Public Service Commission filed a motion to cancel the certificates of service authority and accompanying tariffs of Pelzer Communications Corporation's ("Pelzer") to provide telecommunications services in the State of Missouri.

In File Number CA-2007-0109, the Commission granted Pelzer a certificate of service authority to provide basic local exchange telecommunications services. The Company's tariff, P.S.C. MO No. 2, was also approved.

In File Number XA-2007-0110, the Commission granted Pelzer a certificate of service authority to provide interexchange service authority. The Company's tariff, P.S.C. MO No. 1, was also approved.

Staff states in its motion that Pelzer contacted and informed Staff that Pelzer planned to cease operations and no longer provide services in Missouri on or before September 13, 2010. Staff recommends that the Commission cancel the company's certificates of service authority to provide basic local and interexchange telecommunications services, and the company's accompanying tariffs.

On November 3, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than November 15, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Pelzer’s request and Staff’s motion, the Commission finds that the certificates of service authority and accompanying tariffs granted to Pelzer Communications Corporation, shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide basic local exchange telecommunications services granted to Pelzer Communications Corporation, in File Number CA-2007-0109, is canceled.

2. Pelzer Communications Corporation’s tariff, P.S.C. MO No. 2, is canceled.

3. The certificate of authority to provide interexchange telecommunications services granted to Pelzer Communications Corporation, in File Number XA-2007-0110, is canceled.

4. Pelzer Communications Corporation’s tariff, P.S.C. MO No. 1, is canceled.

5. This order shall become effective on November 29, 2010.
6. This case may be closed on November 30, 2010.
