# ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY AND APPLICABLE TARIFFS

Issue Date: August 23, 2022

Effective Date: September 22, 2022

On August 10, 2022, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of service authority to provide basic local exchange, non-switched local exchange and interexchange telecommunications services granted to Call One, Inc. (Company). On February 25, 2011, the Commission granted the certificate of service authority at issue to United Communications Systems, Inc. d/b/a Call One in File No. LA-2011-0230. In File No. LN-2012-0371, the Company's name change to Call One, Inc. was recognized by the Commission. Staff's motion states that the Company wishes to voluntarily relinquish its authority. The Company has two applicable tariffs that it also requested be cancelled – YL-2012-0564 and YL-2012-0565.

On August 11, 2022, the Commission issued its order that anyone wishing to respond to Staff's motion or request a hearing do so by filing a pleading no later than August 22, 2022. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, the Commission may cancel the certificate based on Staff's motion.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority and the applicable tariffs – Tracking Nos. YL-2012-0564 and YL-2012-0565 – of Call One, Inc. are canceled.
2. This order shall be effective on September 22, 2022.
3. This file shall be closed on September 23, 2022.
