

5. The undersigned agrees to subject himself to the governance of the Missouri Rules of Professional Conduct as set forth in Rule 4. The undersigned also certifies that


neither he nor any member of his firm is under suspension or disbarment by any court.

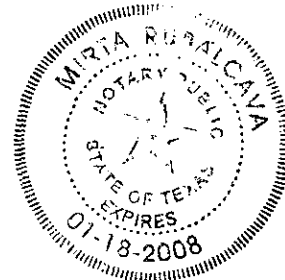

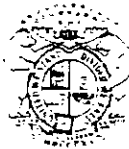


