

Services and the Company as Competitive)


2. The introductory paragraph of the Application is amended as follows:

("nii" or "Applicant"), through the undersigned counsel, and hereby files this verified application pursuant to 4 CSR 240-2.060 and 4 CSR 240-3.510, and respectfully requests that the Missouri Public Service Commission ("Commission") issue an order that (a) grants Applicant a Certificate of Authority to provide resold Basic Local Exchange, Non-Switched Local Exchange and Interexchange Telecommunications Services in the State of Missouri, (b) grants competitive status to Applicant and (c) waives certain Commission rules and statutory provisions pursuant to Section 392.420, RSMo 2000. [footnote not repeated]

3. Except as set forth above, the remainder of the Application is unaltered by this amendment.

WHEREFORE, applicant, nii communications, LTD. L.P. respectfully requests that the Commission grant it a certificate of service authority to provide basic local, non-switched local and interexchange telecommunications services as herein requested, classify nii and its proposed services as competitive, and grant a waiver of the aforesaid statutes and regulations.
