COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and in response to the Commission's December 28, 2018

Order Directing Staff to File Progress Report (Order), states as follows:

- 1. The Commission's Order directing Staff to file a progress report no later than March 29, 2019 was issued the same day, December 28, 2018, when Staff filed its third progress report in this matter. Staff also filed progress reports on June 29, 2018, and December 29, 2017.
- 2. The Commission opened this investigation docket on June 28, 2017, in response to a Motion to Open Case filed by Staff on June 6, 2017, in which Staff requested the Commission open an investigation into the City of New Florence's (City) compliance with the Commission's gas safety rules.
- 3. As shown in the attached Progress Report memorandum, Staff has continued to work with the City regarding its compliance with Commission Rule 4 CSR 240-40.030, and the City has made progress in its compliance with the rule; however, there are still some outstanding compliance concerns that the City is working with Staff to resolve. Staff met with the City on March 11, 2019, to discuss the actions required to meet requirements of 4 CSR 240-40.030. Therefore, Staff recommends that the Commission keep this docket open. Staff proposes to provide an additional progress

report, or pursue other actions as appropriate, no later than June 30, 2019.

WHEREFORE, Staff submits the attached Progress Report pursuant to the Commission's December 28, 2018 Order, and requests the Commission issue an order directing Staff to file an additional progress report or other filing as appropriate no later than June 30, 2019.

DATE: March 29, 2019

As discussed in Staff's December 28, 2018 progress report, the City of New Florence ("the City") had a change in personnel operating its natural gas system in August of 2018. Since that time, Staff has met with the City's Utility Superintendent on several occasions to discuss outstanding compliance issues from previous inspections, and to perform additional inspections that were due to be conducted. Since the last progress report, the City has continued to work towards completing required training and qualification of employees to operate its natural gas system. In the interim, the City of New Florence has continued to use the services of the City of Hermann natural gas department to perform covered tasks on the City of New Florence natural gas system that require qualified operating personnel.

A. <u>Standard Records and Field Inspection:</u>

A standard records and field inspection was conducted on February 12, 2019. An inspection summary letter was provided to the City on February 25, 2019 describing areas of probable violation and areas of concern. Staff requested a response within 30 days of the February 25, 2019 letter, indicating any actions that have been taken or will be scheduled as a result of the Staff's comments. The City sent a response to Staff's inspection summary dated March 11, 2019. Staff is reviewing this response and will follow-up with the City, as necessary.

B. Operations and Maintenance and Emergency Response Plan Inspection:

An inspection of the City's Operations and Maintenance (O&M) and Emergency Response¹ program plan was conducted December 18, 2018. An inspection summary letter was provided to the City on January 3, 2019, indicating revisions needed to achieve compliance with the requirements of 4 CSR 240-40.030(12)(C) and (12)(J). Staff requested a response within 30 days indicating any actions that have been taken or will be scheduled as a result of the inspection and an estimated schedule for completion of scheduled actions. The City sent a response to Staff's inspection summary dated March 11, 2019. The response indicates that the City is working on revisions to the O&M and Emergency Response Plan and will provide a copy when revisions are completed.

C. Public Awareness Plan and Effectiveness Evaluation Inspection:

A Public Awareness Plan (PAP) and Public Awareness Plan Effectiveness Evaluation (PAPEE)² inspection was conducted on September 11, 2017, and an inspection summary was sent to the City on September 12, 2017. The City has completed some but not all actions required by 4 CSR 240-40.030(12)(K).

Staff met with the City on March 11, 2019, to discuss the actions required to satisfy the requirements of 4 CSR 240-40.030(12)(K). The City plans to begin taking actions to complete compliance during March, 2019, and anticipates completion by the end of April 2019. Staff will continue to monitor completion.

D. Operator Qualification Program Inspection:

An Operator Qualification (OQ)³ program inspection was conducted on October 31, 2017. An inspection summary was sent to the City on November 6, 2017. Staff requested a response within 30 days, and has not yet received a response.

Staff met with the City on March 11, 2019, to discuss the actions required to satisfy the requirements of 4 CSR 240-40.030(12)(D). As of the March 11, 2019 meeting, the City had made none of the required plan amendments as requested in Staff's inspection summary sent to the City

on November 6, 2017. Staff requested that the City provide a written response to its November 6, 2017 letter outlining a plan to address remaining items from the inspection.

E. <u>Distribution Integrity Management Inspection:</u>

The required elements for a Distribution Integrity Management Program (DIMP) are in 4 CSR 240-40.030(17). A DIMP inspection was conducted on October 30, 2017. An inspection summary was sent to the City on November 7, 2017. The City provided a revised distribution integrity management program plan on June 11, 2018. The revised plan does not satisfy all of the requirements of 4 CSR 240-40.030(17)(D). Staff met with the City on June 14, 2018, to discuss the required amendments. A follow-up letter was sent detailing these requirements on June 21, 2018, and requesting a revised plan by July 30, 2018. Staff has not yet received a response.

Staff met with the City on March 11, 2019, to discuss the actions required to satisfy the requirements of 4 CSR 240-40.030(17). Staff requested that the City provide a written response to its July 30, 2018, letter outlining a plan to address remaining items from the inspection.

Staff's Recommendation:

The City has made progress towards achieving compliance since the recent turn-over of the City's operating personnel. Staff recommends that the Commission keep the case open. Staff intends to continue monitoring for compliance and proposes to provide an additional progress report, or take other action as necessary, no later than June 30, 2019.
