## ORDER REJECTING APPLICATION AND DIRECTING STAFF INVESTIGATION

On November 25, 2009, nii communications, ltd., and NOW Communications,

Inc., known in Missouri as Now Communications Incorporated of Delaware, d/b/a Cleartel

Communications, submitted an Application for the Cancellation of Certificates of Service

Authority and Withdrawal of Tariffs.

The application indicated that nii is a Texas limited partnership, and that NOW is a Delaware corporation. The application was signed and verified by Randy Muench, President of nii and NOW. There is no indication that Mr. Muench is an attorney licensed in the State of Missouri. A corporation and a limited partnership are artificial entities created by law. As such they cannot appear or act in person. In legal matters, they must be represented by licensed attorneys.<sup>1</sup>

The Commission issued a Notice of Deficiency on November 30, 2009, allowing nii and NOW until December 30, 2009, to correct the deficiency in their application. No response was filed. The Commission will therefore reject this application.

Because it appears the companies want to cancel their authority, the Commission will direct its Staff to investigate the situation and file its own motion to cancel the certificates and tariff if it believes that is appropriate.

## THE COMMISSION ORDERS THAT:

1. The application filed by NOW Communications, Inc., known in Missouri as Now Communications, Incorporated of Delaware, d/b/a Cleartel Communications, and nii communications, Itd., on November 25, 2009, is rejected.

2. The Staff of the Missouri Public Service Commission shall investigate whether these certificates and tariff should be canceled and take any action appropriate as a result of that investigation.

3. This case may be closed.

4. This order shall become effective upon issuance.
