This file concerns Summit Natural Gas of Missouri, Inc.'s (SNGMo) application for approval of its Cost Allocation Manual (CAM), which regulates the purchase of goods or services from an affiliated entity. Upon request, this file has been stayed since August 26, 2019, as the Commission considers revisions to its rules governing affiliate transactions. Those revisions have not progressed due to COVID-19.

The parties' status update of July 12, 2021, continues to state that SNGMo is not currently conducting affiliate transactions that would impact the company's Purchased Gas Adjustment or its Actual Cost Adjustment. The parties request the Commission continue its stay and direct a further status report.

The Commission finds the joint request reasonable, will continue the stay placed on these proceedings, and will order a further status report.

- 1. The stay of proceedings granted in this case will continue.
- 2. The parties shall file a status report no later than October 12, 2021.
