**JOINT MOTION TO MODIFY PROCEDURAL SCHEDULE**

COME NOW Charter Fiberlink-Missouri LLC, (Charter) CenturyTel of Missouri LLC (CenturyTel), the Staff of the Missouri Public Service Commission (Staff) and the Office of the Public Counsel (OPC), by and through counsel, and state the following to the Commission:

1. On November 21, 2007, the Commission issued its Order Adopting A Procedural Schedule. In that Order the Commission established March 7, 2008 as the date by which parties should file surrebuttal testimony, and March 14, 2008 as the date for the filing of a List of Issues, List of Witnesses and Order of Cross Examination.

2. Charter and CenturyTel need additional time within which to prepare surrebuttal testimony in part to allow response time for pending data requests.. Staff and OPC have no objection to modifying the time to file surrebuttal and moving the date for the filing of the issues and witness list and order of cross examination.

3. The parties jointly propose that the procedural schedule be modified as follows:
