Subject: Recommendation regarding Name Change and Approval of Proposed Title Pages and Adoption Notices

On May 9, 2006, Logix Communications, LP (Logix), a competitive telecommunications company, filed a letter requesting that the Commission acknowledge its new corporate name, Logix Communications, L.P. Logix also submitted a copy of its Articles of Conversion of Western Communications, Inc. converting to Logix Communications, LP, and a Certificate of Registration of Foreign Limited Partnership in the name of Logix Communications, LP from the Missouri Secretary of State.

At the request of Staff, Logix filed a substitute title page and adoption notice on May 23, 2006. The Staff has reviewed Logix's proposed title pages and adoption notices and recommends the Commission issue an order recognizing Logix's new corporate name, and approving the following proposed tariff pages to become effective June 22, 2006:
