ORDER RECOGNIZING NAME CHANGE AND ACKNOWLEDGING ADOPTION OF TARIFF

On August 24, 2015, Preferred Long Distance, Inc. ("Company") requested that the Missouri Public Service Commission recognize its name change to Preferred Long Distance, Inc. d/b/a Telplex Communications and Preferred Long Distance, Inc. d/b/a Telplex. The Company also provided notice that it is initiating Voice over Internet Protocol services and Commercial Mobile Radio Services. The Company filed a separate substitute tariff sheet and tariff adoption sheet for both Telplex and Telplex Communications (Tracking Nos. JL-2016-0064 and YL-2016-0075). The submitted tariff sheets have a September 1, 2015 effective date.

On August 28, 2015, the Commission's Staff filed a recommendation stating that the Company has complied with the filing requirements for certificated company name changes, as specified in Commission rule 4 CSR 240-2.062. Based on its review, Staff recommends that the Commission recognize the Company's name changes and the submitted tariff sheets.

After reviewing the notification and recommendation of Staff, the Commission finds the name changes shall be recognized and recognizes the adoption of the new tariff sheets.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Preferred Long Distance, Inc. to Preferred Long Distance, Inc. d/b/a Telplex Communications.
2. The Commission recognizes the name change of Preferred Long Distance, Inc. to Preferred Long Distance, Inc. d/b/a Telplex.
