On October 21, 2016, the Staff of the Commission filed a Gas Incident Report of its findings regarding this investigatory docket. Staff's report included a number of recommendations for Laclede Gas Company involving identification, monitoring, and evaluation of similar threats in the future. The Commission will direct Laclede to file a response to Staff's report, including a statement of whether the company agrees to comply with Staff's recommendations.

1. No later than December 7, 2016, Laclede Gas Company shall respond to Staff's Gas Incident Report as described in the body of this order.
2. This order shall be effective when issued.
