ORDER GRANTING MOTION FOR EXTENSION OF TIME

On January 6, 2016, the Commission issued an *Order Granting Motion and Directing Filing*, which established a deadline of June 20, 2016 for Staff to file a report of its findings regarding this investigatory docket. On June 3, 2016, Staff requested an extension of that filing deadline until October 21, 2016, in order to conduct additional field investigation and collect more information regarding the incident. Ten days have elapsed and no party has objected to the requested extension.¹ The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time filed on June 3, 2016, is granted.
2. The deadline for Staff to file a report of its findings is extended until no later than October 21, 2016.

¹ Commission rule 4 CSR 240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.

3. This order shall be effective when issued.
