On June 30, 2023, Staff filed a progress report indicating New Florence has not yet come into full compliance with those gas safety rules. Staff does not believe there is any immediate danger, but explains there are still outstanding compliance concerns that New Florence is working with Staff to resolve. Staff proposes to file an additional progress report by December 15, 2023.

The Commission will direct Staff to file the additional progress report it proposes.

- 1. The Commission's Staff shall continue its investigation of the City of New Florence's compliance with the Commission's rules regarding gas safety and shall file a progress report regarding its investigation no later than December 15, 2023.
