## MOTION FOR EXPEDITED TREATMENT OF REVISED TARIFF SHEETS

COMES NOW McLeodUSA Telecommunications Services, Inc. (McLeodUSA), by and through counsel, and pursuant to 4 CSR 240-2.065(2) and 4 CSR 240-2.080(16), for its Motion for Expedited Treatment for Approval of Revised Tariff Sheets ("Motion"), states as follows:

- 1. McLeodUSA has this date filed revised interexchange tariff sheets (which have been assigned Tariff Tracking No. JX-2004-0182) to implement interexchange telecommunications service multi-year service packages as will be permitted as of August 28, 2003, under legislation recently enacted by the Missouri General Assembly and signed into law by the Governor (HB 208). The proposed revised tariff sheets (P.S.C. MO No. 5, Sheets 48, 48.2, 48.3, 48.4 and 63) have been filed with the 30-day effective date required by 4 CSR 240-3.545(25); however, McLeodUSA respectfully requests the Commission grant expedited treatment of these tariff revisions and permit them to take effect on less than 30 days notice. Specifically, McLeodUSA requests the tariff sheets be allowed to take effect on August 28, 2003, rather than September 14, 2003.
- 2. McLeodUSA previously filed revised tariff pages which would have allowed multi-year package discounts through a promotion, but was recently advised by Staff that revisions to McLeodUSA's regular tariff provisions would be required first.

McLeodUSA has filed the required revisions to P.S.C. MO No. 5, as listed and described above, and this Motion for Expedited Treatment, as soon as possible after that discussion with Staff.

- 3. McLeodUSA believes that customers desire the price stability and savings that multi-year service packages provide; thus, approving the subject tariff revisions to take place at the earliest date possible under the new legislation is in the public interest and will in no way be detrimental to Missouri telecommunications customers. McLeodUSA also notes that it has been diligent in its good-faith compliance with Missouri law in this area, and that granting this Motion will prevent McLeodUSA from being put at a continued competitive disadvantage against those carriers who may not have been so diligent about compliance.
- 4. McLeodUSA is also separately filing proposed tariff revisions to its local exchange (CLEC) tariff (P.S.C. MO No. 4) to implement multi-year service packages for basic local service customers, and a separate Motion for Expedited Treatment applicable to those tariff revisions.

WHEREFORE, for the reasons stated above, McLeodUSA respectfully moves the Commission to grant expedited treatment of proposed revised tariff sheets P.S.C. MO No. 5, Sheets 48, 48.2, 48.3, 48.4 and 63, pursuant to 4 CSR 240-2.065(2) and 4 CSR 240-2.080(16) to permit those revised tariff sheets to take effect on August 28, 2003.
