

**CHAIRMAN'S OFFICE** 

By way of background, I work in federal law enforcement in Jefferson City, and my wife is an elementary school teacher in California, Missouri. We live on a farm that is approximately 10 miles north of California, Mo. While we have a mailing address of California, and our children attend the California schools, we live approximately 300 yards north of a section line that is the determining factor which telephone company provides our service. GTE, Jamestown, Mo. is our telephone company.

Prior to the recent flap in the newspaper re Community Optional Service (COS), neither myself or my wife were aware such a service existed. We have two teenage children who attend school in California, Mo. In addition to their calling their friends, we also incur additional telephone expenses with my wife calling her pupil's parents. Also, any parent that wants to call my wife to discuss their child's education must incur a long distance expense.

Because of the above, on August 9, 1994, I wrote both GTE and United telephone which is the company that services California, Mo., asking that they consider jointly petitioning the Missouri Public Service Commission to "re-map" the service area, to allow us to go to the California exchange. (copy of both letters attached). To date, I have not received a reply from either company re this request.

While I can understand that neither company would want to go to the above trouble for one customer, I am upset that neither company at the time contacted us to let us know that "COS" was available to address this type of problem. It has been pointed out in the newspaper that one of the reasons that system is being allowed to discontinue, is low usage. I personally feel the main reason there is low usage, is that the telephone companies fail to let their customers know this service exist. Had I know this service existed, I would have sought to obtain this service several years ago, possibly saving myself hundreds of \$\$ over the past several years.

As a citizen and taxpayer of Missouri, I ask that you re-consider the PSC position on allowing telephone companies to discontinue the COS program.

By way of background, our residence in Moniteau County lies approximately 2/10 of a mile north of the east-west line that borders between section 16/17 and 21-22, Township 46 North, Range 15 West of the 5th P.M. (see attached legal description). Per the Missouri Public Service Commission, the east-west line that borders between section 16-17 and 21-22 is the boundary line with GTE servicing residences to the north of that line, and United Telephone serving residences to the south of that line.

We are currently served by GTE, and subscribe to telephone number (816) 849-2375. We have no complaints concerning this service. All aspects of the service is excellent.

The reason for this request is as follows:

My wife, Beth, is a public school teacher, teaching 5th grade at California Elementary School. As such, she makes every effort to be accessible to the students and their parents after school hours and on weekends. The telephone is the primary means by which parents can contact her to discuss their children. Since the majority if not all of the students live in the "314 area code, 796- exchange", it places an additional financial burden on those parents to place a long distance telephone call to talk to their child's teacher.
