JOINT STATUS REPORT

COME NOW Summit Natural Gas of Missouri, Inc. ("Summit Natural Gas"), the Staff of the Missouri Public Service Commission ("Staff"), and the Office of the Public Counsel ("Public Counsel"), and jointly state as follows:

1. On May 24, 2012, the Commission issued its *Order Granting Joint Request Regarding Continuing Discussions*, approving Summit Natural Gas' request that the parties file monthly status reports until Summit Natural Gas files a Cost Allocation Manual ("CAM") acceptable to all parties, or until the parties notify the Commission that they are unable to reach an agreement. The Commission ordered the parties to file a monthly status report on the last working day of the month until otherwise ordered.

2. Summit Natural Gas filed its application in this case on March 28, 2012. The parties will review the CAM filed in this case in relation to CAMs filed in other cases.
