ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

On August 27, 2021, Mobilitie Management, LLC notified the Commission that it wishes to cancel its authority to provide basic local exchange and non-switched local telecommunications services in Missouri. The Commission granted that certificate of service authority in File No. CA-2016-0260, on April 29, 2016.

The Commission directed its Staff to respond, and on September 13, 2021, Staff filed a recommendation advising the Commission to cancel Mobilitie Management's certificate of service authority.

The Commission has the authority to cancel a certificate of service authority pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the certificate of service authority granted to Mobilitie Management shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of service authority to provide basic local exchange and non-switched local exchange telecommunications services granted to Mobilitie
 Management in File Number CA-2016-0260, is canceled.
 - 2. This order shall become effective on October 13, 2021.
 - 3. This file may be closed on October 14, 2021.
