### **STAFF'S SECOND MOTION FOR EXTENSION**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Staff's Second Motion for Extension*, states as follows:

1. On November 19, 2021, Staff filed its *Staff's Motion for Extension* ("initial motion") in which Staff requested the Commission grant Staff an extension on its recommendation regarding Spire Missouri's compliance tariffs, up to and including, November 30, 2021.

2. Staff noted in its initial motion that an extension would also grant Spire Missouri additional time to work on correcting and refiling tariffs that comply with the Commission's *Amended Report and Order*. Staff also noted in its initial motion that if Staff was required to file its recommendation on November 19, 2021, Staff's recommendation would necessarily be that the tariffs Spire Missouri had filed thus far did not comply with the *Amended Report and Order* and should be rejected.

3. On November 23, 2021, Spire Missouri refiled its compliance tariffs, Tracking No. YG-2022-0162. These refiled tariffs had issue dates of November 23, 2021, and effective dates of December 23, 2021. Spire Missouri noted in its transmittal letter that these tariff sheets were refiled to reflect the Commission's decisions in its *Amended Report and Order*.

4. Staff is in the process of reviewing Spire Missouri's November 23, 2021, compliance tariff filing, Tracking No. YG-2022-0162, and requests the Commission grant Staff a further extension, up to and including December 10, 2021, to file its recommendation on Spire Missouri's tariff filings.

WHEREFORE, Staff requests the Commission grant it an extension, up to and including, December 10, 2021, to file its recommendation; and grant such other and further relief as is reasonable in the circumstances.
