## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: July 14, 2005 Effective Date: July 24, 2005

This order cancels the certificate of service authority and accompanying tariff of Local Line America, Inc.

On June 14, 2005, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Local Line America. The Commission issued a certificate of service authority to provide basic local telecommunications services to Local Line America in Case No. TA-97-251. The Commission granted Local Line America authority to serve additional exchanges in Case No. TA-2002-139. The Commission has also approved the company's tariff, P.S.C. Mo. Tariff No. 1.

Staff reports that the telephone numbers provided by the company are out of service and Staff is unable to contact the company. The web site of the Missouri Secretary of State's Office lists the company as being in "good standing"; however, the last filing made by the company to that office was April 2, 2004. Staff also reports that Larry Henderson and Mick Johnson of the Commission Staff received an e-mail from Tesa Lamb, Office Manager for Local Line America, on March 31, 2005, which stated that Local Line America is no longer doing business in the state of Missouri. Finally, Staff

reports that the company has not filed an annual report for calendar year 2004 and the company owes no assessment to the Commission.

Local Line America has an approved interconnection agreement with Southwestern Bell Telephone, L.P., d/b/a SBC Missouri; however, the company no longer receives service under the terms of that agreement. Local Line America also has an approved interconnection agreement with Sprint Missouri, Inc. According to Sprint, the company still has two customers receiving service under that agreement, but they were scheduled to "snap-back" to Sprint under Commission rule 4 CSR 240-31.120 no later than July 6, 2005.

Staff served its motion on the address the company provided to the Commission and on its registered agent. No response to Staff's motion was received.

Under Section 392.410, RSMo Supp. 2004, the Commission has the authority to cancel a telecommunications corporation's certificate. After reviewing Staff's motion, the Commission determines that this company is no longer in business in the state. Therefore, the Commission finds that the certificate of service authority granted to Local Line America, along with the accompanying tariff, should be canceled.

To ensure that the company has had every opportunity to respond, the Commission will require its Data Center to serve this order upon the addresses for the company as listed in Staff's certificate of service.

## IT IS THEREFORE ORDERED:

That the certificates of service authority granted to Local Line America, Inc.
in Case Nos. TA-97-251 and TA-2002-139 are canceled.

- 2. That the accompanying tariff, P.S.C. Mo. Tariff No. 1, filed by Local Line America, Inc., is canceled.
- 3. That the Data Center of the Commission shall serve a copy of this order on the following:
