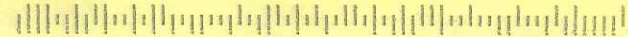

## ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023

Effective Date: August 23, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificates of service authority of SRInternet (SRInternet or the Company) to provide basic local exchange, interexchange, and non-switched local exchange telecommunications services in Missouri. Staff further asked the Commission to cancel SRInternet's registration to provide interconnected voice over internet protocol (IVoIP).

The Commission granted SRInternet authority to provide basic local exchange, intrastate interexchange and non-switched local exchange telecommunications services Case No. LA-2020-0300. The Commission granted a registration to the Company to provide interconnected voice over internet protocol service authority in Case No. DA-2020-0299

Staff's motion states that SRInternet failed to submit an annual report due to the Commission for calendar years 2020 and 2021. In addition, the Company failed to file

its Statement of Revenue report and pay the annual assessment for fiscal year 2023. Staff recommended that the Commission cancel the Company's certificate of service authority and registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the certificate of service authority and registration granted to SRInternet shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificates of service authority to provide basic local exchange, intrastate interexchange and non-switched local exchange telecommunications services granted to SRInternet in File No. LA-2020-0300 is canceled.
2. The registration provide interconnected voice over internet protocol service authority granted to SRInternet in File No. DA-2020-0299 is canceled.
3. This order shall become effective on August 23, 2023.
4. This case may be closed on August 24, 2023.


