Richard S. Brownlee, III, and for its Motion to Remove Suspension  
of Tariff states:


By the Commission's Order of October 21, 1988, it has  
suspended various tariffs, including that filed by Teleconnect  
Company on May 27, 1988. The grounds for said suspension was to

have the "generic operator services case" considered by the Commission.

During the hearing on the "generic case", Public Counsel agreed that they would have no objection to Teleconnect initiating services in the State of Missouri. With this concession, there were no other remaining parties that had any objection to Teleconnect Company providing services in the State of Missouri.

As such, Teleconnect Company believes that its tariff should no longer be suspended and therefore requests the Commission to remove the suspension so that it can place its Missouri tariff into effect.


