MOTION TO FILE ISSUES MEMORANDUM FOUR HOURS OUT OF TIME

Comes now the Staff of the Missouri Public Service Commission (Staff), by and through the Commission's Office of General Counsel, and for its Motion to File Issues Memorandum Four Hours Out of Time respectfully states as follows:

1. The Commission modified the procedural schedule in the above referenced case by it order dated May 1, 1997. The modified procedural schedule stated in pertinent part:

Issues Memorandum filed

June 16, 1997

2. Due to unforseen circumstances the hearing memorandum will not be ready to file until 12:00 noon, Tuesday, June 17, 1997. Because of a misunderstand relating to the deadline to provide party positions, five (5) of the twelve (12) parties to the docket did not provide the Staff with their positions on the relevant issues until after 2:00 p.m. on the date the Issues Memorandum was due. The Staff was unable to incorporate all of the late party positions and obtain party signatures in time to file the Issues Memorandum by the 5:00 p.m. deadline. The Staff declined to exercise its right to file the Issues Memorandum without the missing parties, because of the honest misunderstandings involved and the limited value to the Commissioners of an Issues Memorandum missing over a third of the party positions.

WHEREFORE, the Staff respectfully requests that the Commission accept the Issues Memorandum to be late filed on June 17, 1997.
