On behalf of Missouri Gas Utility, Inc. ("MGU" or "Company"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing certain tariff sheets in electronic form consisting of revised natural gas rate schedules. The rate schedules are listed on Appendix A, bear a date of issue of August 29, 2007, and an effective date of September 28, 2007.

The purpose of this filing is to implement a general rate increase for natural gas service provided by MGU. The revised natural gas rates were designed to produce an additional \$443,131 in gross annual natural gas revenues (excluding gross receipts and sales taxes) or a 28.42 % increase over existing natural gas revenues.

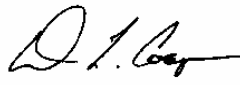
