This is to inform you that pursuant to the Order of the Missouri Public Service Commission in Case No. TO-99-254, Southwestern Bell Telephone (SWBT), GTE Midwest Inc., Fidelity Telephone and Sprint (collectively the PTCs) will be released from their Primary Toll Carrier (PTC) responsibilities in the exchanges served by the Missouri Local Exchange Companies (LECs) listed below on the dates shown below.

The August 1999 Missouri Primary Carrier System Tables (30 and 80) which were provided to you or to your billing vendor the first week of September reflected this fact for companies where the PTCs have already been released of their responsibilities.

The ending of the PTC responsibility means that your company must now send records (for intraLATA toll traffic that uses the Feature Group C network and terminates to the LECs shown below) directly to the companies listed below rather than the former PTC. In addition the Order in Case No. TO-99-254 requires the PTCs to provide the Missouri LECs Category 11 rather than 92 type records beginning April 1, 2000. The Missouri LECs have requested that your company also send them Category 11 records as well.

Records for any intraLATA toll minutes that your company sends over the Feature Group C network for termination to an exchange of one of the companies listed below should be sent directly to that company for calls on or after the effective date shown below.

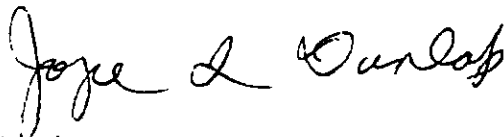
