LIST OF CONTESTED ISSUES

COMES NOW the Staff of the Missouri Public Service Commission, on behalf of all parties to this case, and submits the following Proposed List of Issues, for the evidentiary hearing to be held in this case February 21-22, 2002:

- 1. On September 13, 2001, the Staff filed its complaint against the Respondent, St. Louis County Water Company. On November 8, 2001, the Commission issued its Order Adopting Procedural Schedule, in which it directed the parties to agree upon and file, by no later than January 25, 2002, a list of issues to be determined in this case by the Commission. The said Order also made the Staff responsible for actually drafting and filing the list of issues, and required the other parties to cooperate with Staff in the development of the list of issues.
- In addition to the Staff and County Water, the list of parties to this case includes the
 Office of the Public Counsel and St. Louis County, Missouri.
- 3. The parties have conferred and have unanimously identified the following Issue No. 1 is a contested issue:

Issue No. 1: Is the Company's tariff sheet P.S.C. MO No. 6 Original Revised SHEET No. TR 17.0 unjust, unreasonable, or more than allowed by law or by order or decision of the Commission, and, if so, what changes to the tariff would be proper?

In addition, the Staff contends that the following Issue No. 2 is a contested issue. However, County Water and St. Louis County contend that Issue No. 2 is not contested.

Issue No. 2: Does Commission approval of a tariff also constitute approval of a contract that is filed with the tariff and on which the tariff is based?

WHEREFORE, the Staff submits the foregoing List of Contested Issues.
