ORDER APPROVING AMENDMENT TO INTERCONNECTION AGREEMENT

Issue Date: June 21, 2023

Effective Date: July 21, 2023

This order approves an amendment to a negotiated Interconnection Agreement between the parties filed by Southwestern Bell Telephone Company, d/b/a AT&T Missouri.

On May 12, 2023, AT&T Missouri filed an application with the Commission for approval of an amendment to their negotiated Interconnection Agreement with Lingo Telecom, LLC d/b/a Lingo under the provisions of the Federal Telecommunications Act of 1996. AT&T Missouri is certificated with the Commission as an incumbent local exchange carrier and is registered to provide IVoIP service. Lingo is a competitive local exchange and interexchange carrier and is registered to provide IVoIP service.

Although Lingo is a party to the Agreement, it did not join in the application. On May 25, 2023, the Commission issued an order making Lingo a party in this case and directing any party wishing to request a hearing to do so no later than June 9, 2023. No requests for hearing were filed.

Under Section 252(e) of the Act, any Interconnection Agreement adopted by negotiation must be submitted to the Commission for approval. The Commission may reject an Agreement if it finds that the Agreement is discriminatory or that it is not consistent with the public interest, convenience and necessity.

On June 13, 2023, the Staff of the Commission filed a recommendation. Staff recommends that the Agreement as amended be approved and notes that the Agreement as amended meets the limited requirements of the Act in that it is not discriminatory toward nonparties and is not against the public interest.

The Commission has considered the application, the supporting documentation, and Staff's recommendation. Based upon that review, the Commission finds that the Agreement as amended meets the requirements of the Act in that it does not discriminate against a nonparty carrier and implementation of the Agreement as amended is not inconsistent with the public interest, convenience and necessity.

The application represents that the applicant has not had contact with the Office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

1. The amendment to the Interconnection Agreement between AT&T Missouri and Lingo, filed on May 12, 2023, is approved.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on July 21, 2023.
4. This file may be closed on July 22, 2023.
