JOINT STATUS REPORT

COME NOW Alltel Communications, Inc. and WWC License L.L.C. ("ALLTEL" or "Respondents"), and the petitioning small incumbent local exchange companies ("Petitioners"), (collectively, "The Parties"), and, pursuant to the *Order Suspending Procedural Schedule* issued in this case on August 7, 2006, and the *Order Granting Extension of Time* issued on September 25, 2006, respectfully state to the Missouri Public Service Commission ("Commission") as follows:

The Parties have continued diligently working, and making progress, toward resolution of the issues in this case. In fact, as of this date, individual Interconnection Agreements have now been filed with the Commission as to 18 of the 19 RLEC Petitioners in this arbitration, to reflect such resolution, and a new docket has been established for each. Only the Craw-Can Telephone Cooperative agreement has yet to be filed, and it has been sent from one party to the other for signatures within the last two working days. Thus, the Parties will require limited, additional time to complete the process of finalizing and filing all the negotiated agreements herein.

The arbitration deadline in this case is currently November 17, 2006, per the Commission's *Order Granting Joint Motion to Extend Arbitration Deadline and Setting Procedural Schedule* issued on July 13, 2006. The Parties request additional time, until

October 17, 2006, for completing the filing of their negotiated agreements or filing another status report herein.

A Status Chart is attached for the convenience and information of the Commission, listing the nineteen (19) ILECs who are Parties to the instant arbitration, showing the new case number assigned to each of the eighteen (18) Interconnection Agreements which have now been filed arising out of the settlements reached in the instant case and the date on which each Application for approval of said Interconnection Agreements was filed.
