**PETITION FOR LEAVE TO APPEAR PRO HAC VICE

In support of the Petition, Paul N. Jones states as follows:

1. I am an attorney for the NNSA not admitted to practice before the courts of the State of Missouri but I am admitted to practice before the courts in the states of New Mexico, Texas, Massachusetts and Mississippi and also Washington D.C and have been in the active practice of law since 1999.
2. I certify that no attorney for NNSA nor DOE is under suspension or disbarment by any of the courts of New Mexico, Texas, Massachusetts, Washington, D.C. or Mississippi.


