Mobilitie, LLC ("Mobilitie," or the "Company"), by its undersigned counsel and pursuant to Mo. 4 CSR 240-28-0.030(9), hereby submits this notification of name change in connection with the *pro forma* Assignment of Certificate of Service Authority from Mobilitie to its subsidiary, MO Network Utility Transport, LLC ("MO Network Transport") ("Transaction"). Mobilitie respectfully requests the Commission change the name on the Certificate of Service Authority from Mobilitie to MO Network Utility Transport, LLC. In support of this Notification, and pursuant to Mo. 4 CSR 240-28-0.030(9)(A) Mobilitie provides the following information:

1. A statement clearly setting out the old name and new name of the Company (Mo. 4 CSR 240-28-0.030(9)(A)(1)):

Pursuant to the Transaction, the old and new names in which the Company offered and will offer services to customers in the State of Missouri is as follows:

Old Name: Mobilitie, LLC

New Name: MO Network Utility Transport, LLC
