MOTION TO AMEND APPLICATION FOR VIDEO SERVICE AUTHORIZATION

Pursuant to and in accordance with 4 CSR 240-2.080, GTC Video, Inc. ("GTC" or "Company"), by and through its undersigned counsel, hereby moves the Missouri Public Service Commission ("Commission") for authority to amend the Application for Video Service Authorization that GTC filed on August 28, 2007. In support of its motion, the Company states as follows:

- 1. On August 28, 2007, GTC filed an Application for Video Service Authority pursuant to Section 67.2679(7), RSMo 200 (Cum Supp. 2007).
- 2. In paragraph 6 of that application, and also in the attachment to the affidavit of Jon C. Stouffer, which was appended to the application as part of Appendix B, the Company stated that the Cities of Carthage and Neosho, Missouri, were among the political subdivisions for which GTC sought authority to construct, install, operate, and maintain a video network and to supply video service.
- 3. Subsequent to filing its application, GTC determined that it should not have sought video service authority within the Cities of Carthage and Neosho but, instead, should have sought authority to serve the unincorporated area within Jasper County.

references in the application to the Cities of Carthage and Neosho were made in error and, further, because the Company does not want to seek video service authority for territory located within the Cities of Carthage and Neosho but, instead, wants to seek authority to serve unincorporated areas in Jasper County, GTC moves the Commission for authority to amend the Company's application by: 1) deleting the references to the Cities of Carthage and Neosho that appear in paragraph 6; 2) adding Jasper County to list of political subdivisions in paragraph 6 for which GTC seeks video service authority; and 3) substituting the attached, revised affidavit of Jon C. Stouffer for the affidavit that was filed with the original application.
