STAFF MOTION

COMES NOW the Staff of the Missouri Public Service Commission and for its motion, states as follows:

1. On July 29, 2014, Momentum Telecom, Inc. (“the Company”) requested the Commission cancel its certificate of service authority to provide basic local exchange and interexchange telecommunications service. The Company was granted authority to provide such telecommunications services on May 3, 2008, in File No. LA-2008-0282. The request is filed in EFIS under BCES-2015-0043. The Company has no effective tariffs.

2. Because the Company requested cancellation of its service authority and it is not providing telecommunications services in Missouri, the Staff recommends the Commission cancel its certificate.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

WHEREFORE, the Staff recommends that the Commission cancel the Certificate of Service Authority for Momentum Telecom, Inc. to provide local exchange and interexchange telecommunications service in Missouri, and cancel any accompanying tariff(s).
