The Missouri Public Service Commission is reserving ruling on *Request for Leave to Amend Application* ("motion")¹ and ordering Pac-West Telecomm, Inc. ("Pac-West") to file an amended tariff with a 30-day effective date, or a withdrawal of its pending tariff, no later than April 5, 2011.

On March 7, 2011, Pac-West filed the pending tariff with an application for a certificate of service authority through counsel not admitted to practice in Missouri, contrary to Missouri Supreme Court Rule 9 and Commission Regulation 4 CSR 240-2.040. By order dated March 8, 2011, the Commission ordered Pac West to appear through counsel no later than March 18, 2011. Pac-West did not comply. By order dated March 24, 2011, the Commission ordered Pac why the Commission should not dismiss the application and reject the tariff no later than March 31, 2011. Pac West did not comply.

On April 4, 2011, Pac West filed the motion with Missouri counsel's entry of appearance replacing non-Missouri counsel with the motion. The Commission will reserve ruling on the motion pending compliance with this order. The pending tariff bears an

effective date of April 7, 2011, so the Commission will order Pac West to either withdraw the pending tariff, or file an amended tariff with a 30-day effective date, or file a 30-day extension of the effective date.

THE COMMISSION ORDERS THAT:

1. As to the tariff to which the Commission assigned Tracking No. YL-2011-0451,

Pac-West Telecomm, Inc., shall file either:

- a. a withdrawal;
- b. an amended tariff with a 30-day effective date; or
- c. a 30-day extension of the effective date.
- 2. Pac-West Telecomm, Inc., shall comply with this order no later than April 5, 2011.
- 3. This order shall become effective immediately upon issuance.
