MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE TO PROVIDE PRIVATE PAY TELEPHONE SERVICE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificate of Service Authority respectfully states as follows:

- 1. On March 30, 1998, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide private pay telephone service to K.C. Telecom Services, L.L.C. (Company) in Case No. TA-98-370.
- 2. On May 4, 2004, Staff received a FY-2005 Statement of Revenue from the Company indicating "N/A[,] Sold Business 01/02." A copy of the statement is attached hereto and made a part hereof. Staff responded by advising the Company that it "will need to request cancellation of the Certificate of Service Authority..."
- 3. According to the Missouri Secretary of State's website, the Company's status is "Active."
- 4. Staff has performed an investigation and has determined that the Company owes less than four dollars in assessments and has not filed its FY-2006 Statement of Revenue.
- 5. Pursuant to Section 392.520.1, RSMo 2000, entities providing coin operated telephone services may be exempt from the requirements of Section 392.390 (1), RSMo 2000,

which requires telecommunications companies to file annual reports. The Commission has exempted coin operated telephone service providers from such filing.

6. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5, RSMo Supp. 2004, which provides:

"Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. <u>State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission</u>, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of K.C. Telecom Services, L.L.C. to provide private pay phone service.
