AT&T MISSOURI'S APPLICATION FOR APPROVAL OF AN INTERCONNECTION AGREEMENT

AT&T Missouri, pursuant to Section 252(e) of the Telecommunications Act of 1996 ("the Act") and 4 CSR 240-3.513(1), respectfully submits this Application for Approval of an Interconnection Agreement ("Agreement") by and between AT&T Missouri and Local Access LLC and requests that the Commission approve the Agreement.

In support of this Application, AT&T Missouri states:

1. AT&T Missouri is a Delaware corporation with its principal Missouri office at One AT&T Center, Room 3520, St. Louis, Missouri 63101. It may be contacted at the regular and electronic mail addresses and telephone and facsimile numbers of its attorneys, as set out under the signature block of this Application. AT&T Missouri is authorized to do business in Missouri³ and its fictitious name is duly registered with the Missouri Secretary of State.⁴ AT&T Missouri is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications

service" within the State of Missouri, as each of those phrases is defined in Section 386.020, RSMo 2000.

- 3. AT&T Missouri has no final unsatisfied judgments or decisions against it from any state or federal agency or court, which involve retail customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application. AT&T Missouri has one pending action against it, brought by end-user customers, which involves retail customer service or rates.⁵
- 4. AT&T Missouri does not have any annual report or assessment fees that are overdue in Missouri.
- 5. AT&T Missouri seeks approval of the Agreement submitted herewith, which has been signed by the parties. The Commission must approve the Agreement unless it determines that the Agreement (or any portion thereof) (1) discriminates against a telecommunications carrier not a party to the Agreement, or (2) the implementation of such Agreement is not consistent with the public interest, convenience, and necessity.⁶
- 6. AT&T Missouri states that the Agreement does not discriminate against a telecommunications carrier not a party to the Interconnection Agreement. AT&T
