STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

- 1. On March 27, 2007, Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri submitted a tariff filing to introduce 511 service. 511 is a national abbreviated dialing code to be used exclusively for access to travel information services. AT&T Missouri also filed a motion for expedited treatment asking that the tariff filing become effective within ten business days, i.e., April 10. On March 29, AT&T Missouri substituted a page to handle a pagination issue.
- 2. In the attached Memorandum, labeled Appendix A, the Staff states that the tariff filing meets the requirements of applicable statutes and rules, recommends that the tariff filing go in to effect, and states that it has no objection to AT&T Missouri's request for expedited treatment.

WHEREFORE, the Staff recommends that the Commission approve AT&T Missouri's 511 tariff filing at the Commission's earliest convenience.

Summary:

On March 27, 2007, AT&T, an incumbent local exchange carrier, made the instant tariff filing, Filing No. JI-2007-0678. The instant filing proposes to: (1) introduce AT&T's 511 service (described below) and (2) change the name of AT&T's 211 service (from "SBC 211" to "211"). The instant tariff filing has an effective date of April 26, 2007.

Simultaneously on March 27, 2007, AT&T filed a Motion for Expedited Treatment, which created Case No. IT-2007-0354. This motion cited the Missouri Department of Transportation's (MoDOT) interest in ordering the 511 service due to forthcoming road construction in the St. Louis area. This motion requested the instant tariff filing become effective within ten business days from the date filed.

On March 28, 2007, the Commission ordered Staff to file a recommendation "regarding the Motion for Expedited Treatment, and its accompanying tariffs, no later than April 2, 2007". Staff recommends Tariff Filing No. JI-2007-0678, be allowed to go into effect.

511 Service Background / Description:

511 was assigned as a nationwide dialing code for traffic information services by an FCC order released July 31, 2000¹.

In its July 31, 2000 order, beginning on page 10, paragraph 15, the FCC gave federal, state, and local transportation agencies discretion regarding the implementation of 511 service:

We do not specify parameters for cost recovery and other technical issues, contrary to suggestions of some commenters. Instead, we leave with

federal, state, and local government transportation agencies the discretion to determine the deployment schedule and the type of transportation information that will be provided using 511, similar to how we handled this issue with respect to 311 in the *N11 First Report and Order*. (footnotes omitted)

The FCC also delegated limited jurisdiction to state commissions. Later from the same paragraph:

State public utility commissions may continue to exercise jurisdiction over N11 codes to the extent necessary to ensure that carriers comply with transportation agencies' requests to deploy 511 expeditiously.

According to the Federal Highway Administration, as of December 31, 2006, all or portions of approximately 30 states have deployed 511 service². Generally, 511 providers offer information on road closures and current traffic conditions. These 511 service providers often have interconnected web sites that give similar traffic service information.

Tariff / Case Discussion:

Staff reviewed AT&T's tariff filing and states that the tariff meets the requirements of all applicable statutes, specifically, one or more of the following: Sections 392.200(8), (12); 392.245; 392.455(3), (4); 392.515(1) and 392.500(2) RSMo. In addition, the tariff filing does not conflict with the following Commission rules: 4 CSR 240-3.545 (4), (6), (7), (8 C,G,H), (9), (15), (16), (19); 4 CSR 240-31.065(1), (2), (3); 4 CSR 240-32.150(5), 32.160(1), (2), 32.190; 4 CSR 240-33.040(4), 33.045(2), 33.050(4) and 33.070(2).

Staff reviewed cost information provided by AT&T for the 511 service; and made queries and analyzed responses about the cost information. AT&T currently has tariffs in effect for similar services: 211 service (information and referral service for nonprofit organizations), 311 service (nonemergency calls to municipalities and other government agencies), and 811 service (call before you dig service). Staff also reviewed the rates and corresponding cost studies for each of these services as part of its review of the instant tariff.

Staff requested and received a substitute page for Section 35, 5th Revised Sheet 1 in order to handle a pagination issue. No substantive changes were made in this substitution.

Conclusion:

Staff recommends Tariff Filing No. JI-2007-0678, be allowed to go into effect. Staff has no objection to AT&T's request for expedited treatment (effective date of April 10, 2007) as requested by AT&T in Case No. IT-2007-0354. Staff is unaware of any other filing which affects or which would be affected by this tariff and case filing.
