**ORDER APPROVING EXPEDITED TARIFF**

Issue Date: July 9, 2012

Effective Date: July 13, 2012

On June 28, 2012, IAMO Telephone Company issued a tariff that will alter its state access tariff provisions regarding intrastate Voice over Internet Protocol (VoIP) traffic. Along with its tariff, the company filed a motion asking the Commission to approve the tariff to take effect on July 13. The company explains that the revised tariff will bring its rates into compliance with the requirements established by the Federal Communications Commission (FCC) in a recent order. The FCC requires that the revised rates go into effect by July 13, so the company asks the Commission to approve the revised tariff to take effect on that date.

The Commission directed its Staff to file a recommendation regarding the tariff no later than July 6. The Commission also ordered that any other party wanting to file a recommendation regarding the tariff do so no later than July 6.

On July 3, the Commission's Staff filed its recommendation advising the Commission to approve the tariff to be effective on July 13 as requested. Staff explains that doing so will make the tariff consistent with federal law and will not have a negative effect on customers. No other party has filed a recommendation regarding the tariff

Based on the recommendation of its Staff, the Commission finds that the submitted tariff should be approved on less than thirty days' notice.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheet submitted under Tariff No. YI-2012-0869 by IAMO Telephone Company is approved, effective on and after July 13, 2012. The specific tariff sheet approved is:
