NOTICE OF HEARING

On December 13, 1978, Control Center, Inc., (Applicant) by its

Attorneys filed with the Commission an "Application for Continuance" wherein it requested that the above-styled matter be continued to a date to be set by the Commission. A hearing in this case had been set for December 27, 1978, for the purpose of receiving Protestants' evidence in this matter. Applicant tried and rested its case at a hearing held on October 20, 1978.

On December 14, 1978, Protestant Central Mobile Phone, Inc., (Central) informed the Commission by letter that it had no objection to the continuance through the holiday season, but requested that it be set for hearing as soon as possible thereafter. On December 15, 1978, Protestant Capital City Telephone Company concurred in Protestant Central's request. Said continuance was granted.

The presiding examiner in this matter has contacted the above parties regarding the rescheduling of this matter and has been informed that Applicant desires a hearing date in April of 1979. Protestants strenuously urge an earlier setting.

Applicant's continuance request states that additional time is required to ascertain what equipment and frequencies will be available if the proposed authority is granted. The Commission, having considered that Applicant has rested his case, concludes that the matter should be reset at an earlier time as requested by Protestants. Said conclusion is based upon the fact that the remaining testimony will be provided by Protestants only. A hearing is hereby scheduled as set forth below.

It is, therefore,

ORDERED: 1. That Case No. TA-79-66 be, and the same is, hereby set for further hearing in the Commission's hearing room on the tenth floor of the Jefferson State Office Building, Jefferson City, Missouri, at 10:00 a.m., on February 14, 1979, for the purposes set forth hereinabove and for any other matters as they become apparent.

ORDERED: 2. That this Order shall become effective on the date hereof.
