Dear Mr. York:

Missouri Gas Energy needs to contact you to discuss your future plans for the Malang Trailer Park. MGE employees have tried to contact you via telephone several times.

The Missouri Public Service Commission granted Missouri Gas Energy an additional year extension until June 30, 2009 to replace the mains and service lines at your trailer park. At the time MGE filed for an extension, you indicated that the park would probably be closed within a year or two and the property would be redeveloped in some way.

We need to know your current plans for the trailer park. If you do not plan on closing the trailer park, MGE needs to replace the mains and service lines within the trailer park by June 30, 2009. As part of the regulatory proceeding, we need to communicate your plans for the trailer park to the Missouri Public Service Commission within the next couple of weeks.
