#### **NOTICE**

COMES NOW Spire Missouri Inc. ("Spire" or "Company"), by and through counsel, and in follow-up to Spire's March 28, 2022 filing, provides the following Notice:

On March 28, 2022 Spire filed its Response to the Staff's March 18, 2022 Report. In Spire's Response the Company stated that it would endeavor to work with the Staff of the Missouri Public Service Commission ("Staff") and the Office of the Public Counsel ("OPC") to come to an agreement on what the Company believes to be an outstanding issue. The purpose of the stipulation is to clarify which costs are to be included in the regulatory asset authorized by the Commission<sup>1</sup> and therefore provide the Company the accounting authority necessary to begin to utilize the regulatory asset.

Spire, Staff and OPC are still discussing this matter and will submit a filing to this Commission addressing this issue as expeditiously as possible. While the Parties are discussing a stipulation on this specific matter, the Commission should not delay its Order regarding the Staff's March 18, 2022 Report.

WHEREFORE, Spire asks the Commission to accept this Notice, and issue an Order approving overhead treatment consistent with Staff's Report.
