**ORDER GRANTING MOTION FOR EXTENSION OF TIME**

On October 28, 2009, AT&T Communications of the Southwest, Inc., and Southwestern Bell Telephone Company, d/b/a AT&T Missouri (collectively, AT&T), filed a motion requesting that the Commission suspend and investigate the access services tariff submitted by Bandwidth.com CLEC, LLC, on October 7, 2009. The Commission issued an order setting a response deadline of November 12, 2009. On November 6, 2009, Bandwidth filed a motion for extension of time, to December 11, 2009, to file its response. Bandwidth seeks additional time to attempt to resolve matters raised in AT&T's motion. Bandwidth states that AT&T and the Commission's Staff do not object to the request contingent upon extension of the tariff's effective date and a provision for time to reply to Bandwidth's response, agreed upon as December 18, 2009.

Bandwidth has extended the effective date of its tariff from November 22, 2009, to December 22, 2009.

Inasmuch as the parties have agreed upon the requested extension and Bandwidth has extended the tariff effective date, the Commission finds it reasonable to grant Bandwidth's motion, but will amend the filing dates. Given the December 22 tariff effective date, December 16 is the last possible Agenda date for the Commission to decide

this matter. Therefore, the deadlines for Bandwidth's response and for replies and Staff's pleading must be shortened.

**THE COMMISSION ORDERS THAT:**

1. Bandwidth.com CLEC, LLC's Motion for Extension of Time for Response is granted with the amendment discussed above.
2. Bandwidth.com CLEC, LLC, shall respond to AT&T Communications of the Southwest, Inc., and Southwestern Bell Telephone Company, d/b/a AT&T Missouri's motion no later than December 9, 2009.
3. The Staff of the Commission shall file its recommendation or response no later than December 14, 2009.
4. AT&T Communications of the Southwest, Inc., and Southwestern Bell Telephone Company, d/b/a AT&T Missouri, may reply to Bandwidth.com CLEC, LLC's response no later than December 14, 2009.
5. This order shall become effective upon issuance.
