

Comes now Compass Telecommunications, Inc. ("Compass"), and makes the following amendments to its Application for Certificate of Service Authority and for Competitive Classification.

Compass filed its application for Certificate of Service Authority and for Competitive Classification with the Commission on August 23, 1999. Compass amends that Application for Certificate of Service Authority to provide resold and facilities-based local telecommunications services, local exchange telecommunication services, exchange access services, and inter-exchange telecommunications services in the state of Missouri and to classify the company and its services as competitive as follows: In paragraph 8 of said application, Compass requests that certain statutes and regulations be waived. In addition to those regulations specified in paragraph 8, Compass requests the waiver of the following additional regulations:




