# CERTIFICATION TO PROVIDE TELECOMMUNICATIONS SERVICES

On July 13, 2022, Metro Fibernet, LLC d/b/a MetroNet, pursuant to Section 392.550, RSMo, filed an application for registration to provide Basic Local Telecommunications Services and Interexchange Telecommunications Services in the St. Joseph service area in addition to its existing authority in Jefferson City and O’Fallon service areas, which was granted in File No. TA-2022-0046.

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

**THE COMMISSION ORDERS THAT:**

1. MetroNet is registered to provide Basic Local Telecommunications Services and Interexchange Telecommunications Services in the exchanges set forth in the

affidavit attached to the application and restated above.

2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.

3. This order shall become effective on August 1, 2022.

4. This file may be closed on August 2, 2022.
