PROPOSED PROCEDURAL SCHEDULE

COMES NOW Kansas City Power & Light Company (“KCPL”) for its Proposed Procedural Schedule states to the Missouri Public Service Commission (“Commission”) as follows:

1. On November 13, 2003, the Commission issued an Order Setting Aside Order Dismissing Complaint and Setting Prehearing Conference. In that Order, the Commission directed the filing of a Proposed Procedural Schedule by the parties no later than December 11, 2003.
2. On December 4, 2003, KCPL, Mr. Moses, and representatives from both the Public Service Commission and Office of Public Counsel participated in the prehearing conference.
3. At the prehearing conference, the parties engaged in settlement negotiations and reached an agreement in principal to settle this matter.
4. On December 5, 2003, KCPL sent a copy of the Stipulation & Agreement to settle this matter to Mr. Moses by U.S. mail, faxed it to the number provided by Mr. Moses, and left Mr. Moses a message that KCPL had mailed and faxed him the Stipulation & Agreement.
5. Therefore, KCPL requests that the Commission relieve the parties of the requirement of filing a Proposed Procedural Schedule by December 11, 2003. KCPL agrees to file the executed

Stipulation & Agreement or report back to the Commission the status of negotiations by December 24, 2003.

WHEREFORE, KCPL prays that the Commission relieve the parties of the requirement of filing a Proposed Procedural Schedule by December 11, 2003, as set out above.
