
## **KCP&L to Allconnect Transfer Guidelines**

Upon completion of a Turn On/Transfer order, a message will appear in the customer information system (CIS+) indicating if a customer is Eligible or Not Eligible. If the customer is eligible for Allconnect:

Advise the customer:

- They will be transferred to Allconnect.
- Their order will be verified.
- Their confirmation number will be provided.
- They will be offered other services for their home (such as home phone, TV, internet)
