This is to advise the Public Service Commission that Public Counsel has not taken a position in this complaint case brought by Charter Fiberlink, LLC against CenturyTel of Missouri, LLC concerning the resolution and enforcement of the Interconnection Agreement. But Counsel reserves its right to submit a brief and take a position in this case after the submission of all evidence, testimony, cross-examination and responses to Commission questions.

While Public Counsel does not usually participate in inter-carrier complaint cases and arbitrations of terms and enforcement of interconnection agreements, Public Counsel believes that this case involving a cable company CLEC and an incumbent local exchange company may have some public policy or other significance in future provision of telecom services and competition in Missouri. Although Public Counsel may not take a very active role in the hearing, it will participate even though Public Counsel is not offering any prefiled testimony.
