MOTION TO OPEN CASE AND CANCEL CERTIFICATES OF SERVICE AUTHORITY AND ACCOMPANYING TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves that the Commission open a case and cancel ICG Telecom Group, Inc.'s certificates of service authority to provide basic local telecommunications services and to provide intrastate interexchange and non-switched local exchange telecommunications services in Missouri, as well as its tariffs. In support of its Motion, Staff respectfully states as follows:

- 1. As of August 14, 1998, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide intrastate interexchange and non-switched local exchange telecommunications services, to ICG Telecom Group, Inc., in Case No. TA-98-577. The Commission also approved ICG Telecom Group, Inc.'s tariff, Tariff Mo PSC No. 1.
- 2. On October 6, 1998, the Commission granted a certificate of service authority to provide basic local telecommunications services to ICG Telecom Group, Inc., in Case No. TA-98-589. The Commission also approved ICG Telecom Group, Inc.'s tariff, Tariff Mo PSC No. 2.
- 3. ICG Telecom Group, Inc. has indicated in its confidential Statement of Revenue it submitted to the Commission that it is no longer in business. On that document, the company's

representative indicated that it was reporting no Missouri jurisdictional revenue and that it no longer wished to maintain its operating certificate in Missouri. The notarized statement of revenue containing this statement was submitted to the Commission by the president of the company and is available on a highly confidential basis from the Commission's Electronic Filing and Information System.

- 4. The company also submitted a letter to the commission from its controller indicating that the company no longer wished to retain its certificate. See Appendix A.
- 5. In its Annual Report submitted most recently to the Commission, the company reported no access lines.
- 6. ICG Telecom Group, Inc. has no past due annual reports or assessments to the Commission. No formal complaints have been filed against the company since the commencement of the Electronic Filing and Information System.
- 7. ICG Telecom Group, Inc. is a Colorado corporation reflected as being in good standing by the Missouri Secretary of State's website.
- 8. Because ICG Telecom Group, Inc. has requested cancellation of its certificate and because it is not providing telecommunications service in Missouri, the Staff recommends that the Commission issue an order canceling ICG Telecom Group, Inc.'s certificates and tariffs.
- 9. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2005), which provides:

[&]quot;Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

10. This pleading is being served on the address provided by the company to the Commission via certified mail, as well as upon its Missouri registered agent.

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of ICG Telecom Group, Inc. to provide basic local telecommunications services and to provide intrastate interexchange and non-switched local exchange telecommunications services in Missouri, as well as its tariffs, Tariff Mo PSC No. 1 and Tariff Mo PSC No. 2.
