- My name is Patricia A. Kasper and I am a Staff Manager in the Ordering and
 Provisioning Process Management District in AT&T Consumer Services. I have
 over 20 years' management experience with AT&T. I am currently responsible
 for managing the Dial 1 provisioning process for consumer long distance services.
- 2. My prior experience with AT&T includes managing the development and implementation of billing requirements to support the availability of pricing plans and promotions in response to competitive activities in the marketplace and managing the time and cost process with approximately 1,200 external billing suppliers in support of key marketing initiatives.
- 3. I have caused to be prepared a portion of the data included in AT&T Communications of the Southwest, Inc.'s Report to the Missouri Public Service Commission. Specifically, I have caused to be prepared and I am responsible for the data related to the number of intraLATA orders from customers in the independent LEC territories that AT&T has accepted in error.
- That data I presented are broken down into three categories based upon how AT&T processed the order.

- The first category of data represents the number of intraLATA orders from customers in the independent LEC territories that AT&T has accepted but has not processed.
- 6. The second category of data represents the number of intraLATA orders from customers in the independent LEC territories that AT&T has accepted in error and sent to the LEC for processing. The LECs either processed the orders, putting the customers onto AT&T's intraLATA network, but has not yet sent confirmation to AT&T or the LECs has simply held the orders and has not processed them. At the end of April, 1999 AT&T received notice from each LECs that specific NPA-NXXs were being opened up for 1+ IntraLATA competition. As a result, the NPA-NXXs were added to systems and internal tables used to edit orders prior to distribution for processing. When AT&T opted not to offer 1+ IntraLATA services, there was a failure in the internal notification process. As a result the NPA-NXXs were not removed from our internal provisioning systems, and these orders were sent to the LECs. This error was corrected on July 23, 1999. Most of the orders in this category were sent to Alltel Communications, Inc. or IAMO Telephone Company.
- 7. The third category of data represents the number of intraLATA orders from customers in the independent LEC territories that AT&T has accepted and sent to the LEC for processing. The LEC then processed the orders and put the customers on those orders onto AT&T's network and has sent confirmation to AT&T. These orders were sent to the LEC because of the failure in the notification process described above. This error was corrected on July 23, 1999. Orders in this category were sent only to IAMO Telephone Company.

- 1. My name is Andrew Meissner, Division Manager, Customer Care Platform, responsible for the management of the systems infrastructure and tools used by associates in handling customer inquires in the Customer Sales and Service Centers.
- 2. The Missouri Public Service Commission has required AT&T to report the number of requests for 1+ intraLATA toll service in the exchanges served by the independent LECs in Missouri that AT&T has declined. At the time AT&T was required to report that data, AT&T was not capturing this information. This is because AT&T has agreements with the small independent LECs for them to act as AT&T's billing agent for their customers. Because the small independent LECs act as the billing agent, these accounts are not automatically maintained in AT&T's Residential Account Management Platform. Therefore, AT&T was not collecting the requested information.
- 3. To comply with the Commission's directive, AT&T has put in place a process to capture this data. Under this process, when an AT&T customer representative receives an incoming call from a customer in an exchange served by the independent LECs in Missouri that is requesting 1+ intraLATA toll service, that

representative will be instructed to complete an input screen to capture that data. That data can then be summarized by NPA-NXX code and reported.

4. The facts that I have presented are true and correct to the best of my knowledge.

- 1. My name is R. Matthew Kohly. I am employed by AT&T in its Law and Government Affairs organization as Regulatory Manager Government Affairs. In this position I am responsible for assisting in the development and implementation of AT&T's regulatory activities in Missouri.
- 2. I have caused to be prepared a portion of the data included in AT&T

 Communications of the Southwest, Inc.'s Report to the Missouri Public Service

 Commission. Specifically, I have caused to be prepared the Estimated Number of 1+ IntraLATA Orders Received by AT&T, the Estimated Minimum Number of 1+ IntraLATA Orders Declined by AT&T, the Estimated Number of 1+ IntraLATA Orders Declined by AT&T, and the Estimated Maximum Number of 1+ IntraLATA Orders Declined by AT&T.
- The Estimated Number of Orders Received by AT&T is based upon the number of orders received by AT&T from the exchanges served by Alltel Communications, Inc. As the affidavit of Patricia A. Kasper indicates, prior to July 23, 1999, AT&T was incorrectly accepting orders in the exchanges served by Alltel Communications, Inc. Because AT&T was accepting these orders in the normal course of business, this data were available to use as a proxy for the rest of the exchanges served by the small independent LECs where AT&T was not

accepting orders. The result is an estimate based upon the number of orders received per day, per thousand AT&T customers applied to the total number of access lines in each exchange. This estimate is based upon the assumption that the number of orders received is directly proportional to the number of access lines in an exchange.

In some exchanges where AT&T accepted 1+ intraLATA orders, the estimated number of 1+ intraLATA orders received was less than the actual number of orders accepted. In these instances, the actual orders accepted by AT&T was substituted for the estimate.

- 4. The Estimated Number of 1+ Orders Declined by AT&T is simply the Estimated Number of Orders Received by AT&T minus the Total Number of 1+ IntraLATA Orders Accepted by AT&T.
- 5. The Estimated Minimum Number of Orders Declined by AT&T is zero. AT&T knows of no method to reasonably estimate the Minimum Number of 1+ IntraLATA Orders Declined.
- 6. The Estimated Maximum Number of Orders Declined by AT&T is the estimated number of access lines that have chosen AT&T as their Primary Interexchange Carrier ("PIC"). AT&T does not have data for the actual number of lines PIC'd to AT&T by exchange is unavailable so it was assumed that seventy percent of the access lines have chosen AT&T. This estimated maximum relies upon the assumption that every customer who has selected AT&T as their interLATA PIC has contacted AT&T requesting they carry their 1+ intraLATA traffic as well.

7. The assumptions and calculations for which I am responsible are reasonable and accurate to the best of knowledge, information, and belief.
