MOTION TO CANCEL REGISTRATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the registration of Windjammer Communications, LLC ("Company") to provide Interconnected Voice over Internet Protocol service in the state of Missouri. For this Motion, Staff respectfully states as follows:

- 1. On October 18, 2008, the Commission granted the Company authority to provide Interconnected Voice over Internet Protocol services in certain exchanges in the state of Missouri in Case No. DA-2009-0105.
- 2. On November 20, 2012, the Commission received a ceasing operation statement from the Company stating that as of October 15, 2012, the Company no longer has operations in Missouri. (See Attachment A).
- 3. Because the Company is no longer providing service in Missouri, the Staff recommends the Commission cancel the Company's registration.
- 4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

5. The Company remains deficient in the filing of its 2009 and 2010 annual reports. The Company is current on the payment of the Commission's fiscal year assessments.

WHEREFORE, Staff recommends the Commission cancel the registration of Windjammer Communications, LLC to provide Interconnected Voice over Internet Protocol service in the state of Missouri.
