**APPLICATION FOR EXTENSION OF TIME  
TO FILE ANNUAL REPORT**

COMES NOW Level 3 Communications on behalf of Looking Glass Networks, Inc. ("Applicant" or "LGN"), by and through counsel and pursuant to Section 392.210.1 RSMo, 4 CSR 240-3.540(1) and (7), and 4 CSR 240-2.060, and requests an extension of time, until June 15, 2010, within which to file its 2009 Annual Report with the Missouri Public Service Commission ("Commission"). In support of its application, Applicant states the following:

1. Applicant was a Delaware corporation with principal office and place of business located at 1025 Eldorado Blvd., Broomfield, Colorado (CO) 80021. Applicant was a wholly-owned indirect subsidiary of Level 3 Communications, Inc., a publicly traded (NASDAQ: LVLT) Delaware corporation headquartered at 1025 Eldorado Blvd., Broomfield, CO 80021. The nature of Applicant's business was telecommunications. The certificate of good standing for LGN was filed in Case No. TO-2009-0251 and is incorporated herein by reference per 4 CSR 240-2.060(G). As a result of orders issued by the Commission in that case, the customers of LGN have been transferred

to Level 3 Communications and the certificates and tariff of LGN have been canceled.<sup>1</sup>

2. During 2009, LGN provided telecommunications services in Missouri by authority, and within the jurisdiction, of the Commission. Therefore, LGN is required to file an annual report with the Commission for 2009.

4. Applicant's annual report respecting its Missouri telecommunications operations during 2009 is due to be filed on April 15, 2010.

5. Applicant requires, and hereby requests, an extension of time of two (2) months, up to and including June 15, 2010, within which to file its annual report. Although auditors are at work compiling the necessary information with which to

complete the report, they will not be able to complete their work in time for the Applicant to meet the April 15, 2009 deadline. The additional time requested herein is necessary to complete the 2009 financial statements and other financial and company data.

6. This request is not for purposes of delay. If granted, it will not prejudice any other party, but will allow the Applicant to accurately compile the needed documentation and information for its annual report to the Commission.

7. Applicant has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates in which action, judgment or decision has occurred within three (3) years of the date of this application.

8. Applicant has no annual report or assessment fees which are currently overdue.

9. There are no cases pending before the Commission in which the Applicant's activities are the primary focus of the proceedings. Therefore, Applicant is not obligated to serve this pleading on parties not named in the certificate of service below.

WHEREFORE, Looking Glass Networks, Inc. respectfully requests that the Commission extend the time within which it may file its annual report to the Commission to June 15, 2010.
