MOTION FOR LEAVE TO FILE 1999 ANNUAL REPORT

Feist Long Distance Service, Inc., now known as Ionex Communications, Inc., (herein referred to as "Feist") by and through its undersigned counsel, moves the Missouri Public Service Commission to grant it leave to file its 1999 Annual Report after the April 15, 2000 deadline. In support of this motion, Feist states as follows:

- 1. On May 23, 2000, Feist sent its 1999 Annual Report to the Missouri Public Service Commission (the "Commission"). Last week, the Commission returned the 1999 Annual Report and stated that Feist needed to have a Missouri attorney submit an original, plus 14 copies of a pleading requesting an extension of time to file its 1999 Annual Report because Feist's report was submitted after the April 15, 2000 deadline.
- 2. Due to administrative oversight and matters associated with Ionex Telecommunications, Inc.'s acquisition of Feist in November 1999, Feist inadvertently failed to timely file its 1999 Annual Report by the April 15, 2000 deadline. Feist now respectfully requests leave to file the attached 1999 Annual Report.

Ionex Telecommunications, Inc. (Ionex Communications, Inc.'s parent company) acquired Feist Long Distance Service, Inc. in November 1999. Feist has since changed its name to Ionex Communications, Inc. The Commission approved the name change of Feist to Ionex Communications, Inc. in Case No. TO-2000-518.

WHEREFORE, Feist Long Distance Service, Inc., now known as Ionex Communications, Inc., respectfully requests that the Missouri Public Service Commission grant it leave to file the attached 1999 Annual Report.
